**PROJECT DESCRIPTION** The applicant, Barry Peterson, on behalf of property owners, Lars Jensen and Anne Komer, is requesting Planning Commission approval of:

- A Design Review Permit to demolish the existing structure and construct a new single-family residential structure, with a two-car car parking deck;
- A Tree Removal Permit to remove five trees; and
- An Encroachment Agreement to construct a portion of the driveway, car parking stalls, and car parking deck with guardrail in the public right-of-way at 38 Lower Crescent Avenue (APN 065-231-32).


**MEETING DAY/TIME** November 30, 2011 at 6:30 P.M.
