NOTICE TO ALL PLAN HOLDERS SUBMITTING BIDS FOR THIS WORK:

You are hereby notified of the following information, changes, clarifications or modifications to the original Contract Documents, Project Manual, Drawings, Specifications and subsequent Addenda. The Addendum shall supersede the original Contract Documents and previous Addenda wherein it contradicts the same and shall take precedence over anything to the contrary therein. All other conditions remain, UNCHANGED.

This Addendum is hereby made a part of the Contract Documents to the same extent as though it were originally included therein.

Add Project Scope - General

The project improves pedestrian facilities on Bay Street and Anchor Street between Humboldt Ave. and Bridgeway. With improved pedestrian facilities it is believed that more people will walk and use transit services.

Project proposes to remove and replace curb gutter and sidewalk to create:

- 1) Wider walking pathways for pedestrians on Bay Street and Anchor Street.
- 2) Improved compliance with the Americans with Disabilities Act.
- 3) Narrower roadway travel ways on Bay Street and Anchor Street.

The Project also extends sidewalk on the North side of Bay from the Entrance of Parking Lot 3 to the Boardwalk at the Sausalito Yacht Harbor.

The project reconfigures driveway entrances to Parking Lot 3 on Bay Street and to Parking Lot 1 on Anchor Street.

Revise Plan Sheet C2 Legend – Remove and Dispose AC is revised to be ADD Alternate and Edge Grind AC Pavement.

Revise Plan Sheet C2 Demolition Note 2. Parking meters will be removed and stored at a location designated by the Engineer.

Revise Plan Sheet C4 Cross Section 1 – Delete Note "Overexcavate Existing AC Subgrade Moisture Condition and replace with "Recompact Subgrade."

CLARIFICATION: Project Plans and Special Provisions include landscaping component. As a result of feedback provided during pre-bid meeting, a budget reevaluation was made. To get to engineers estimate and due to Contract Law restrictions on the amount of Additive Alternate Items that can be included, the landscaping components are deleted from the Bid Items and the Relevant Plan and Special Provisions will remain in the project documents but not used.

CLARIFICATION: Bid Items 32, 33, 34, 35, and 36: – Due to Federal Funding restrictions these items are "non-participating." Private Utilities (Electric, Gas, Telephone, TV) are responsible for adjusting their facilities. We seek bid price to enable the City to offer to have the work performed within the project on behalf of the Utility. These items are necessarily dependent on the Utility Agreeing to reimburse the City. As such these items are "Add Alternatives."
