NOTICE OF PLANNING COMMISSION AND HISTORIC LANDMARKS BOARD PUBLIC HEARING FOR A MODIFICATION OF A DESIGN REVIEW PERMIT AND MINOR USE PERMIT, A VARIANCE AND A SIGN PERMIT AT 558 BRIDGEWAY

You are invited to attend a Planning Commission and Historic Landmarks Board public hearing on the following project.

PROJECT DESCRIPTION

The applicant, Eric Long of Don Olsen and Associates, on behalf of property owner, View Restaurants, LCC, requests a joint Planning Commission and Historic Landmarks Board approval of modifications to a previously-approved Design Review Permit and Minor Use Permit for façade modifications and an expanded outdoor upper level dining deck, a Variance for the encroachment of the upper level outdoor dining deck into the southern side yard and a Sign Permit for new business identification signage for the Trident restaurant. All of the improvements are proposed for the building at 558 Bridgeway (APNs 065-172-12,-13,-15), which is located in the Downtown Historic Overlay Zoning District.
