**DESIGN REVIEW PERMIT AT 24 EDWARDS AVENUE**

You are invited to attend a Planning Commission public hearing on the following project.

**PROJECT DESCRIPTION** The applicants and property owners, Rene and Liz DuboisBlanc, are requesting Planning Commission approval of a Design Review Permit for the construction of two rear exterior decks on the lower and middle levels of a three story single family residence (APN 065-301-15). The project was determined to require a Design Review Permit pursuant to Zoning Ordinance Section 10.54.050.B.4(c) as it has the potential to impair views from other properties.
