

CITY OF SAUSALITO NOTICE OF PLANNING COMMISSION PUBLIC HEARING FOR A DESIGN REVIEW PERMIT AND A TREE REMOVAL PERMIT FOR THE CONSTRUCTION OF NEW DOWNTOWN RESTROOMS ON THE 700 BLOCK OF BRIDGEWAY DR/TRP 12-004

PROJECT DESCRIPTION

The applicant, Werner Associates Architects, on behalf of property owner, the City of Sausalito, is requesting Planning Commission approval of a Design Review Permit for the demolition of the existing downtown restrooms and construction of new downtown restrooms along the 700 Block of Bridgeway between Anchor and Bay Streets (APN 065-073-02). The applicant is also requesting a tree removal permit to remove one protected tree in association with the project.
