60/62 MARION AVENUE

You are invited to attend a Planning Commission public hearing on the following project.

- PROJECT DESCRIPTION** The applicant, Marty Zwick, on behalf of property owner, Peter McGuire, requests Planning Commission approval of the following on the parcel at 60/62 Marion Avenue (APN 065-292-23):
- A Design Review Permit to construct two new detached single family dwelling units;
 - A Tentative Map to subdivide the parcel into a common interest development for a condominium with two units and one common area;
 - An Encroachment Agreement to construct an elevated driveway area and other related improvements in the public right-of-way; and
 - A Tree Removal Permit to remove 20 Protected trees on the project site.
