

LANDMARKS BOARD PUBLIC HEARING FOR A MODIFICATION OF A
DESIGN REVIEW PERMIT AND A NEW SIGN PERMIT AT 660 BRIDGEWAY
DR/SP 11-332**

**You are invited to attend a Planning Commission and Historic Landmarks Board
public hearing on the following project.**

- PROJECT DESCRIPTION** The applicant, Eduard Llorca, on behalf of property owners, Chris Henry, William Henry, and Wynona Henry, requests a joint Planning Commission and Historic Landmarks Board approval of modifications to a previously-approved Design Review Permit for façade modifications, including modifications to the approved entry doors, extension of a second level outdoor deck, shifting of a rooftop mechanical screen, addition of a new skylight and revised exterior colors; and a Sign Permit for new business identification signage for the Barrel House restaurant. All of the improvements are proposed for the building at 660 Bridgeway (APN 065-133-25), which is located in the Downtown Historic Overlay Zoning District.
