

- PROJECT DESCRIPTION** The applicant, William Kirsch, on behalf of the property owner, Harbor Drive, LLC, is requesting Zoning Administrator approval of a Minor Use Permit to allow a temporary Art Show on of May 19th through 20th and September 1st through 3rd of 2012. The Art Show will be located in the parking lot for the Seahorse Restaurant located at 305-307 Harbor Drive.
