Gensler Architects on behalf of the Bank of America is requesting a Design Review Permit and Encroachment Agreement to allow for exterior modifications, including, but not limited to the removal of an existing trellis and installation of new awnings within the public right-of-way abutting the Bank of America building at 750 Bridgeway (APN 065-073-04). The applicant is also requesting a sign permit to allow for business identification signage.
