

CITY OF SAUSALITO NOTICE OF PLANNING COMMISSION PUBLIC HEARING FOR A NONCONFORMITY PERMIT AT 416 NORTH STREET NC 12-105

You are invited to attend a Planning Commission public hearing on the following project.

PROJECT DESCRIPTION

The applicant, David MacLaird, on behalf of the property owner, Gertrude Pearlman, is requesting Planning Commission approval of a Nonconformity Permit for the interior remodel of an existing nonconforming residential structure located at 416 North Street (APN: 065-202-32). The existing residence is currently nonconforming in terms of the amount of floor area and side setback. The applicant is requesting to convert 234 square feet of floor area from the first floor into crawl space, and creating a new 234 square foot bedroom on the third floor, thereby shifting the existing location of the nonconformity.
