

CITY OF SAUSALITO NOTICE OF ZONING ADMINISTRATOR PUBLIC HEARING FOR A MINOR USE PERMIT TO AND SIDEWALK DINING ENCROACHMENT PERMIT AT 2829 BRIDGEWAY (MUP/SDEP 12-114)

PROJECT DESCRIPTION The applicant, Mustafa Halawa, on behalf of the property owner, 2829 Bridgeway, LLC, is requesting Zoning Administrator approval of a Minor Use Permit and Sidewalk Dining Encroachment Permit to create and outdoor dining area in front of Dario's Pizza. The area will consist of a fountain, herb garden and a seating area for five table and 20 seats surrounded by a wrought iron fence in the public right-of-way fronting the restaurant at 2829 Bridgeway (APN 063-151-05).
