## REQUEST

Approval of a **Tree Removal Permit** to allow the removal of one Plum tree located at 420 Napa Street and one Douglas Fir tree located at 420 Napa Street.

Issuance of Tree Removal and Alteration Permits is categorically exempt **Review** from the California Environmental Quality Act (CEQA), in accordance with Section

15301 of the CEQA Guidelines.

## PROJECT DESCRIPTION

The applicant and 420 Napa Street property owner, Mark Rushford, 416 Napa Street property owner, Jesse Goff, has submitted an application for the removal of one Plum tree (disambiguation) located behind the residence of 420 Napa Street and one Douglas Fir tree (Pseudotsuga menziesii) along the property line between 416 and 420 Napa Street.

An Arborist Report was prepared on August 24, 2012 by Certified Arborist, Ken Bovero, to assess the health, structural condition, and suitability for preservation of the Plum tree and Douglas Fir tree located at 420 Napa Street/416 Napa Street.

The Arborist's report identifies the following attributes regarding the trees proposed for removal (see **Exhibit B** for full report):

#### Plum Tree

- Multi-stemmed tree, the trunks are 24, 16 and 16 inches in circumference at breast height (CBH);
- The tree splits into three stems at grade;
- The tree was originally removed 12 to 15 years ago and the stump resprouted creating the multiple stems:
- The roots system is applying thousands of pounds of force against the adjacent retaining wall causing it to crack;
- The tree drops plums causing an increase of rats present of the property;



The arborist states that with the ongoing damage to the retaining wall, the increase of rodents and the poor growth structure of the tree, the plum tree should be removed.

#### **Eugenia Tree**

- The tree is 75 inches in CBH', and splits into two stems at approximately 25 feet;
- The split in the trunk is threatening the 422 and 420 Napa Street residences;
- The tree has been strangled by Ivy and is killing the lower branches and negatively changing the live crown ratio and creating a hazard;
- The lack of low branches adds to the trees instability.

The arborist states that the tree should be removed immediately to eliminate the threat it poses to people the nearby residences.

## **PROJECT ANALYSIS**

The required determinations for approval of a Permit to remove a protected tree are as follows (per Section 11.12.030.B):

- 1. In order to grant a tree removal or alteration permit it must be determined that removal or alteration is necessary in order to accomplish any one of the following objectives:
  - a. To insure the public safety as it relates to the health of the tree, potential hazard to life or property, proximity to existing or proposed structures, and interference with utilities or sewers.
  - b. To allow reasonable enjoyment of the property, including sunlight, and the right to develop the property.
  - c. To take reasonable advantage of views.
  - d. To pursue good, professional practices of forestry or landscape design.

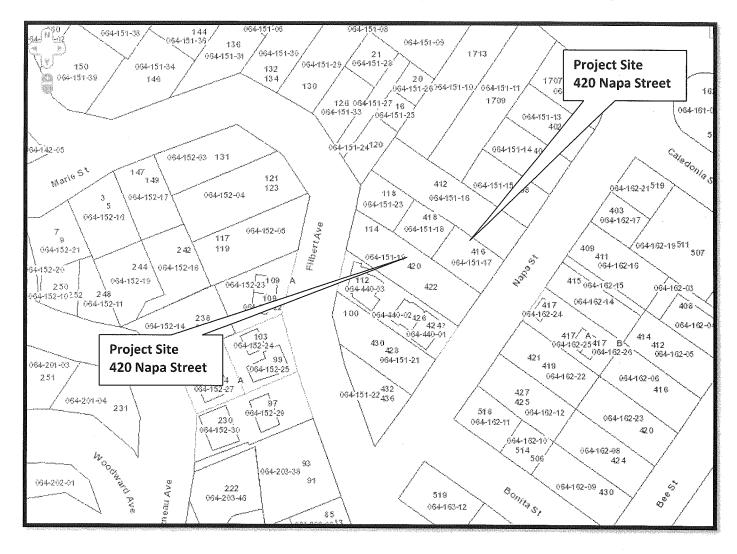
The Plum tree is continuing to damage the adjacent retaining wall, causing an increase of rats frequenting the property, and has a very poor growth structure. Since the Plum tree is causing damage to the property and has a poor structure, removal is required to insure public safety and to pursue good, professional practices of forestry, thus satisfying **Objective a and d** listed above.

The Douglas Fir tree is being strangled by Ivy which has caused the lower branches to die, crating and unstable tree that leans toward nearby residences. Since the Douglas Fir tree poses a hazardous threat to people and the neighboring residences, immediate removal is required to insure public safety as it relates to the potential hazard to life and property, thus satisfying **Objective a** listed above.

- 2. In order to grant a tree removal permit, it must be determined that any one of the following conditions is satisfied:
  - a. The tree to be removed will be replaced by a desirable tree.
  - b. The Tree Committee waives the above requirement based on information provided by the applicant/owner.

Staff has created a Condition of Approval that requires two replacement trees to be a 24-inch box container of desirable species, to be determined by the property owners and shall be planted in a location to be determined by the property owners. There shall be one replacement tree located on each property. The replacement trees shall be planted within 60 days of Plum tree and Douglas Fir tree removal, thus satisfying **Objective a** listed above.

## PUBLIC NOTICE AND CORRESPONDENCE

On September 27, 2012, a notice of this proposal was posted at the front of the subject property, visible to the surrounding neighborhood, and the tree has been tagged.

As of the writing of the staff report the City has received two letters of support for the tree removals (see **Exhibit C**).

### RECOMMENDATION

Staff recommends the Trees and Views Committee approve the attached resolution which makes the required determinations for approval of a Tree Removal Permit to allow the removal of one Cedar tree and one Eugenia tree located between 640 Sausalito Boulevard and 56 Sunshine Avenue (TRP 12-252).

Alternatively, the Trees and Views Committee may:

- Approve the Tree Removal Permit with modifications;
- Continue consideration of the item for additional information; or
- Deny the Tree Removal Permit and identify one or more of the Findings for Denial listed in Section 11.12.030.B.3 (see **Exhibit D**).

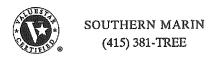

Tree #1 Multi stemmed Plum tree 24"x16"x16" circumference. This tree splits into 3 stems at roughly grade and several times again as you look 4' up the trunk. This tree was removed approximately 12-15 years ago and the stump re sprouted creating all the multiple stems. This trees root system is applying thousands of pounds of force against the wall and causing cracking. This tree is also dropping plums on the ground and increasing the population of rats present on the property by providing food source they enjoy eating remains. Tree value: \$580.00 As mentioned this tree is beginning to crack the wall and has a very poor growth structure that is clearly obvious if you view the co dominant growth structure (stems growing tightly together).

Tree #2 75" CBH Douglas Fir tree: This tree splits into two stems at approximately 25', this bifurcation is threatening 422 Napa as well as 420 Napa this tree has been strangled by lvy for over a decade, killing off the lower branches and negatively changing the live crown ratio and creating a hazard. Low branches create ballast for trees and improving their stability. This tree should be removed before November 2012, to eliminate the threat it poses. Tree value: \$3,600.00 This tree has a number af ailments as for mentioned and is posing a threat to the owner and surrounding properties.

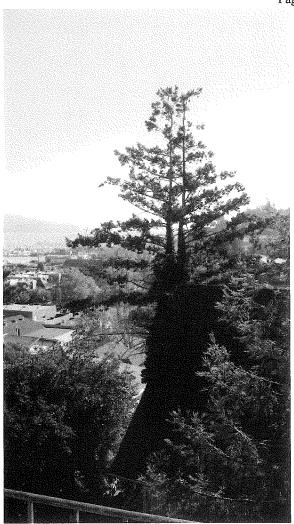

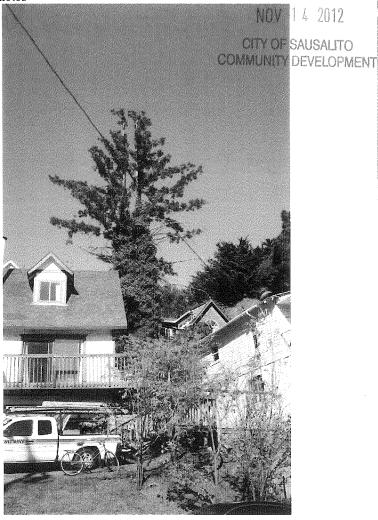

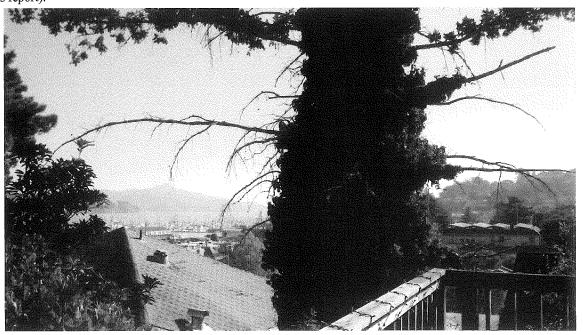

## Tree # 2, Douglas Fir, as referred to in the Arborist Report.

#### a. Reason for removal.

Please see arborist report and page 1 of 3 of the pictures provided. The tree is not healthy and it threatens the homes at 416, 420, and 422 Napa Street. It also blocks the view significantly from 422 Napa Street and 114 Filbert Street.

b. Economic value of the tree based on the ISA guide for plant appraisal.

Please see arborist report.

c. Dangers which may result by the continued existence of the tree if not removed.

The tree is not healthy and it threatens the homes at 416, 420, and 422 Napa Street.

d. Effects of removal on neighboring vegetation.

There will be no effects to the neighboring vegetation.

e. Loss of soil stability that may occur if the tree is removed.

There will be no significant change to the areas around the tree. We will be grinding the tree down to the stump and just below grade so that soil or other material can be put over the location of where the tree was located.

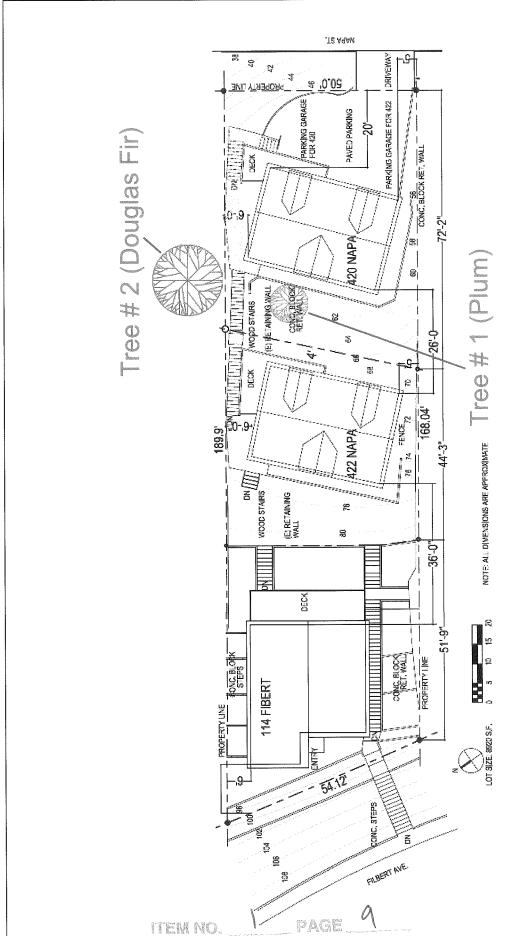
f. Advisability of stump or root removal.

The stump will be ground down to below grade so that soil or other material can be put over the location of where the tree was located.

g. Suggestions for replacement planting.

This tree is located at 416 Napa Street and in conversations with the owner he may plant more bamboo which is currently being used effectively or use another method to maintain a privacy barrier.

# Criteria for Approval or Denial of Tree Removal or Alteration Permits Municipal Code Section 11.12.030.B

- 1. In order to grant a tree removal or alteration permit it must be determined that removal or alteration is necessary in order to accomplish any one of the following objectives:
  - a. To insure the public safety as it relates to the health of the tree, potential hazard to life or property, proximity to existing or proposed structures, and interference with utilities or sewers.
  - b. To allow reasonable enjoyment of the property, including sunlight, and the right to develop the property.
  - c. To take reasonable advantage of views.
  - d. To pursue good, professional practices of forestry or landscape design.
- 2. In order to grant a tree removal permit, it must be determined that any one of the following conditions is satisfied:
  - a. The tree to be removed will be replaced by a desirable tree.
  - b. The Tree Committee waives the above requirement based on information provided by the applicant/owner.
- 3. A finding of any one of the following is grounds for denial, regardless of the finding in "1." above:
  - a. Removal of a healthy tree of a desired species can be avoided by:
    - 1. Reasonable redesign of the site plan, prior to construction
    - 2. a) thinning to reduce density; e.g., "open windows"
      - b) shaping to reduce height or spread, using thinning cuts only (drop crotch)
      - c) heading or topping this is the least preferable method, due to the tree's health and appearance and cost of maintenance.
  - b. Adequate provisions for drainage, erosion control, land stability, windscreen, visual screening, privacy and for restoration of ground cover and/or other foliage damaged by the tree work have not been made in situations where such problems are anticipated as a result of the removal or alteration.
  - c. The tree to be removed is a member of a group of trees in which each tree is dependent upon the others for survival.
  - d. The value of the tree to the neighborhood is greater than its convenience to the owner. The effects on visual, auditory, and wind screening, privacy and neighboring vegetation must be considered.
  - e. The need for protection of privacy for the property on which the tree is located and/or for adjacent properties.

**ATTACHMENT 1: FINDINGS** 

#### TREE REMOVAL PERMIT FINDINGS

In accordance with Municipal Code Section 11.12.030.B, the Trees and Views Committee makes the following findings with respect to the Tree Removal Permit for 416/420 Napa Street.

### Section 11.12.030.B of the Sausalito Municipal Code

- 1. In order to grant a tree removal or alteration permit it must be determined that removal or alteration is necessary in order to accomplish any one of the following objectives:
  - a. To insure the public safety as it relates to the health of the tree, potential hazard to life or property, proximity to existing or proposed structures, and interference with utilities or sewers.
  - b. To allow reasonable enjoyment of the property, including sunlight, and the right to develop the property.
  - c. To take reasonable advantage of views.
  - d. To pursue good, professional practices of forestry or landscape design.

The Plum tree is continuing to damage the adjacent retaining wall, causing an increase of rats frequenting the property, and has a very poor growth structure. Since the Plum tree is causing damage to the property and has a poor structure, removal is required to insure public safety and to pursue good, professional practices of forestry, thus satisfying **Objective a and d** listed above.

The Douglas Fir tree is being strangled by Ivy which has caused the lower branches to die, crating and unstable tree that leans toward nearby residences. Since the Douglas Fir tree poses a hazardous threat to people and the neighboring residences, immediate removal is required to insure public safety as it relates to the potential hazard to life and property, thus satisfying **Objective a** listed above.

In order to grant a tree removal permit, it must be determined that any one of the following conditions is satisfied:

- a. The tree to be removed will be replaced by a desirable tree.
- b. The Tree Committee waives the above requirement based on information provided by the applicant/owner.

The project is conditioned to require two replacement trees to be in a 24-inch box container of desirable species, to be determined by the property owners and shall be planted in a location to be determined by the property owners. There shall be one replacement tree located on each property. The replacement trees shall be planted within 60 days of Plum tree and Douglas Fir tree removal, thus satisfying **Objective a** listed above.

#### ATTACHMENT 2: CONDITIONS OF APPROVAL

This condition of approval applies to the Tree Removal Permit submitted on November 9, 2012.

1. The two replacement trees are to be in a 24-inch box container of desirable species, to be determined by the property owners and shall be planted in a location to be determined by the property owners. There shall be one replacement tree located on each property. The replacement trees shall be planted within 60 days of Plum tree and Douglas Fir tree removal

#### **Advisory Notes**

Advisory notes are provided to inform affected parties of Sausalito Municipal Code requirements, and requirements imposed by other agencies. These requirements include, but are not limited to, the items listed below.

- 1. All tree work shall be performed to the American National Standards (ANSI) A300 pruning standards.
- 2. Pursuant to Municipal Code Section 11.12.040.B, in the event litigation is required to enforce the decision of the Trees and Views Committee the party bringing any private civil action must promptly notify the City of Sausalito's Community Development Department in writing of such action.
- 3. An encroachment permit shall be obtained from the Department of Public Works prior to use of the public right-of-way for non-public purposes (e.g., materials storage, debris box storage) including any and all tree removal activities.
- 4. Pursuant to Municipal Code Section 12.16.140, the operation of construction, demolition, excavation, alteration, or repair devices and equipment within all residential zones and areas within a 500 foot radius of residential zones shall only take place during the following hours:

Weekdays - Between 8:00 a.m. and 6:00 p.m.

Saturdays – Between 9:00 a.m. and 5:00 p.m.

Sundays - Prohibited

City holidays (not including Sundays) – Between 9:00 a.m. and 7:00 p.m.
