PROJECT DESCRIPTION

The applicant, Gordon Atkinson, on behalf of the property owner, Eva Delueze, is proposing to demolish the existing stairs and a portion of the brick wall at the front of the property, and construct a new ADA-accessible ramp. A portion of the frontage adjacent to the sidewalk will have public seating and landscaping. The building is located in the C-C (Central Commercial) Zoning District and Historic Overlay Zoning District at 589 Bridgeway
