

CITY OF SAUSALITO NOTICE OF PLANNING COMMISSION PUBLIC HEARING FOR AN AMENDMENT OF A CONDITIONAL USE PERMIT AND DESIGN REVIEW PERMIT FOR AN EXISTING WIRELESS FACILITY AT 180 HARBOR DRIVE DR/CUP 12-127

You are invited to attend a Planning Commission public hearing on the following project.

PROJECT DESCRIPTION

Applicant, AT&T, on behalf of property owner, Harbor Drive and Associates, is requesting Planning Commission approval of an amendment of a Conditional Use Permit and Design Review Permit for the replacement of six existing panel antennas with six new panel antennas; the installation of three new panel antennas; the installation of a new GPS reception antenna; the addition of six Remote Radio Units; and the addition of four power surge suppression devices at 180 Harbor Drive. AT&T maintains a roof-top wireless facility at 180 Harbor Drive. RF exposure levels due to the proposed operation are calculated to exceed the applicable public exposure and occupational exposure limit as established by the Federal Communications Commission. The RF exposure will be mitigated by restricting access to the antenna locations with security chain barriers.
