

AGENDA TITLE:

Make appointments to the following boards, commissions and committees:

Arts Commission: Appointments to as many of the vacancies as possible at this time:

- Three (3) expired regular terms through January 2011; and
- Three (3) unexpired regular terms through January 2009; and
- Two (2) unexpired regular terms through January 2010; and
- Two (2) vacant Advisory Member seats (no term specified)

Board of Library Trustees: Appointment to the one vacant position on the Board:

One (1) Alternate position; no term specified

Sustainability Commission: Appointments to as many of the vacancies as possible at this time:

- Two (2) unexpired terms through February 2009; and
- Two (2) terms that will expire at the end of February 2008 for the new terms that will run through February 2011

RECOMMENDED ACTION:

Make appointments to the Arts Commission, Board of Library Trustees, and Sustainability to the extent possible as noted above; and/or give direction to staff regarding recruitment for the vacancies.

SUMMARY

Arts Commission:

- Three (3) expired regular terms through January 2011; and
- Three (3) unexpired regular terms through January 2009; and
- Two (2) unexpired regular terms through January 2010; and
- Two (2) vacant Advisory Member seats (no term specified)

A combination of terms that are expiring at the end of January 2008 and six resignations in October and November 2007 have created the vacancies noted above.

There are currently eight applicants to the Arts Commission, five of whom were interviewed by the City Council on January 22, 2008. The three others include Jeffrey Axelrod and Mary Lee Bickford, current members of the Commission who wish to be

considered for reappointment, and Daniel Daniloff, who was out of the country on the interview date. He wishes to be scheduled for an interview once he returns.

The applicants include:

- **Jeffrey Axelrod** Incumbent whose term expires at the end of January 2008; he wishes to be considered for reappointment to a full term through January 2011
- Mary Lee Bickford Incumbent whose term expires at the end of January 2008; she wishes to be considered for reappointment but prefers appointment to one of the shorter unexpired terms rather than a full term that would go through January 2011
- Terry Brejla Former member who had to relinquish his appointment when he moved out of state for a period of time; he was re-interviewed on January 22.
- Nancy Forrest New applicant who was interviewed on January 22, 2008
- Hines New applicant who was interviewed on January 22, 2008
- Sandra Macleod White New applicant who was interviewed on January 22, 2008
- Robert Woodrum New applicant who was interviewed on January 22, 2008
- Daniel Daniloff New applicant who has not yet been interviewed

The current members of the Arts Commission include:

Jeffrey Axelrod term expiring at end of January 2008

Mary Lee Bickford term expiring at end of January 2008 Joshua Goldstein term through January 2010

Incumbents Pippa Murray and Stacy Nimmo, neither of whom wishes to be considered for reappointment when their terms expire at the end of January 2008.

Board of Library Trustees: 1 Alternate Position (no term specified)

For several months the Alternate seat on the Board of Library Trustees has been vacant. With the Board's current work load with the formulation of its Strategic Plan, they would like to have that seat filled so that they can always ensure a quorum at their meetings.

There are two applicants to be considered for appointment to the Library Board:

Sustainability Commission:

Two (2) unexpired terms through February 2009; and

Two (2) terms that will expire at the end of February 2008 for the new terms that will run through February 2011

The vacancies on the Sustainability Commission are the result of the expiration of two terms that will expire at the end of February 2008 (seats of Dane Faber and Ken Kurtzig), one unexpired term through February 2009 that has been vacant for a number of months due to an insufficient number of applicants; and one unexpired term that will run through February 2009 which has been created by the recent decision by Abe Christensen to resign.

Current applicants to the Sustainability Commission include:

- Catherine Carpenter New applicant who was interviewed on January 22. 2008
