

## CITY OF SAUSALITO NOTICE OF PLANNING COMMISSION AND HISTORIC LANDMARKS BOARD PUBLIC HEARING FOR A DESIGN REVIEW PERMIT AND NONCONFORMITY PERMIT AT 801 BRIDGEWAY

You are invited to attend a Planning Commission public hearing on the following project.

## PROJECT DESCRIPTION

The applicant, Safdie Rabines Architects, on behalf of property owner, CMSC Ventures, LLC, requests Planning Commission and Historic Landmarks Board approval of a Design Review Permit at 801 Bridgeway (APN 065-063-46) to allow the following at the Casa Madrona Hotel:

- Modifications to a previously approved Design Review Permit (DR 10-377) to allow for structurally mandated design alterations related to the non-historic Villa Madrona building; and
- Installation of new landscape and hardscape improvements adjacent to the historic William Barrett House; and
- Reconstruction of a building to match a previously-demolished building.

The applicant is also seeking approval from the Planning Commission for a Nonconformity Permit to allow the reconstruction of building within the footprint of a previously demolished building located in the right side yard setback.
