NOTICE OF PLANNING COMMISSION AND HISTORIC LANDMARKS BOARD PUBLIC HEARING FOR A DESIGN REVIEW PERMIT, SIGN PERMIT AND A RECOMMENDATION OF CITY COUNCIL APPROVAL OF AN ENCROACHMENT AGREEMENT FOR EXTERIOR IMPROVEMENTS AND NEW SIGNS AT 675 BRIDGEWAY: DR/SP/EA 13-128

You are invited to attend a Planning Commission and Historic Landmarks Board public hearing on the following project:

PROJECT DESCRIPTION

The applicant, Callison Architects, requests a joint Planning Commission and Historic Landmarks Board approval of a Design Review Permit for exterior modifications and a Sign Permit for new signage on a building located in the Downtown Historic Overlay Zoning District. The modifications include new front entry doors, rooftop mechanical equipment, a new window sign, a hanging sign and a projecting sign.

The applicant also requests a recommendation from the Planning Commission to the City Council to approve an Encroachment Agreement to allow a projecting identification sign to encroach into the Bridgeway public right-of-way fronting 675 Bridgeway; APN 065-131-06.
