

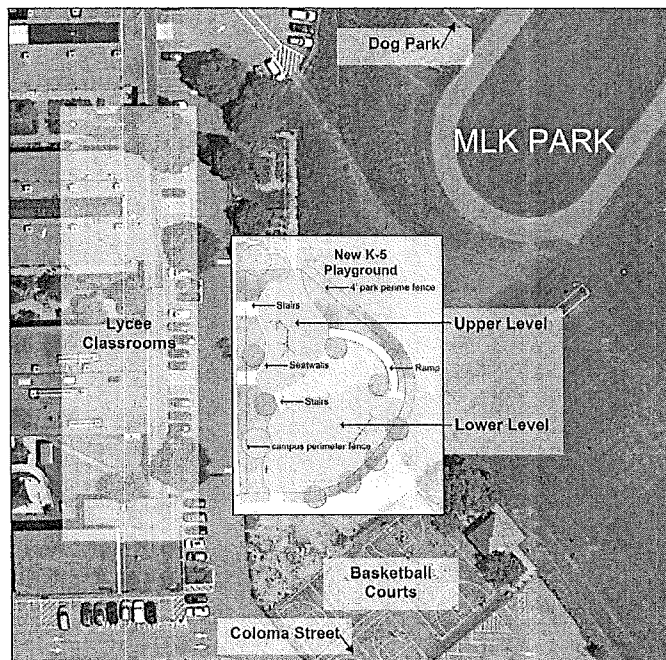

You are invited to attend a Planning Commission public hearing on the following project.

**PROJECT  
DESCRIPTION**

Applicant, Lycee Francais La Perouse, is requesting Planning Commission approval of a Design Review Permit and Tree Removal Permit to construct a 12,000 square foot K-5 grade outdoor playground at MLK Park, to be located across from Building 5 and adjacent to the basketball courts at 100 Ebbtide Avenue (APN 063-170-03). The site is owned by the City of Sausalito. The playground would have perimeter fencing with access gates, drinking fountains, a seat wall, outdoor education area, landscaping, play structures and play surfaces. A cherry tree and a willow tree would be removed.
