

CITY OF SAUSALITO NOTICE OF PLANNING COMMISSION PUBLIC HEARING FOR AN AMENDMENT OF A CONDITIONAL USE PERMIT AND DESIGN REVIEW PERMIT FOR AN EXISTING WIRELESS

FACILITY AT 441-475 Coloma AMENDMENT OF UP/DR 99-111

You are invited to attend a Planning Commission public hearing on the following project.

PROJECT DESCRIPTION

Applicant, Sprint, on behalf of property owner, Westcore Marin, is requesting Planning Commission approval of an amendment of a Conditional Use Permit and Design Review Permit for the replacement of two existing panel antennas with two new panel antennas on the rooftop of 441-475 Coloma. The antennas would be screened within a RF-transparent faux chimney structure (11' tall by 1'-6" feet wide). The applicant also proposes the installation of two new Remote Radio Units on the rooftop screened behind a RF-transparent rectangular screen wall (3'-4" tall by 7' wide and 5' deep). There will also be a new GPS reception antenna on the rooftop and the addition of a battery cabinet in the equipment room at 441-475 Coloma.
