

AGENDA TITLE:

Make appointments to as many of the vacancies on the Sausalito Sustainability Commission as possible at this time:

- One (1) unexpired term through February 2009; and
- Two (2) terms that will expire at the end of February 2008 for new terms that will run through February 2011

RECOMMENDED ACTION:

Make appointments to the Sustainability Commission to the extent possible as noted above; and/or give direction to staff regarding recruitment for the vacancies.

SUMMARY

Sustainability Commission:

- One (1) unexpired term through February 2009; and
- Two (2) terms that will expire at the end of February 2008 for new terms that will run through February 2011

The vacancies on the Sustainability Commission are the result of the expiration of two terms that will expire at the end of February 2008 (seats of Dane Faber and Ken Kurtzig) and one unexpired term that will run through February 2009 which has been created by Abe Christiansen's recent decision to resign before the expiration of his term.

(Note: On January 29, the Council appointed applicant Bill Ring to a vacant unexpired term that will run through February 2009.)

Current applicants to the Sustainability Commission include:

- Dane Faber: Incumbent who wishes to be considered for reappointment
- Catherine Carpenter New applicant who was interviewed on January 22, 2008

Please note: There are three vacancies and only two applicants at this time. Council should make appointments to the extent it feels is possible at this time. Staff will continue recruitment for applicants to be interviewed with regard to appointment to the vacancy that remains.
