**PROJECT DESCRIPTION** The applicant and property owner, Chris Henry requests Planning Commission and Historic Landmarks Board approval of a Design Review Permit to allow for exterior modifications to the building in conjunction with the establishment of a new restaurant on the first floor of the building at 660 Bridgeway (APN 065-133-25). The project requires a joint meeting with the Planning Commission and Historic Landmarks Board as the structure is in the Downtown Historic Overlay Zoning District.


**MEETING DAY/TIME** November 13, 2013 at 6:30 P.M.
