NOTICE TO ALL PLAN HOLDERS SUBMITTING BIDS FOR THIS WORK:

You are hereby notified of the following information, changes, clarifications or modifications to the original Contract Documents, Project Manual, Drawings, Specifications and subsequent Addenda. The Addendum shall supersede the original Contract Documents and previous Addenda wherein it contradicts the same and shall take precedence over anything to the contrary therein. All other conditions remain, UNCHANGED.

This Addendum is hereby made a part of the Contract Documents to the same extent as though it were originally included therein.

Clarification:

Bid Bond: Page 7 of the Bid Proposal is the Bid Bond form. The City of Sausalito will accept Bond/Surety industry equivalent forms in-lieu of completing and submitting the form contained in the Bid Proposal Form.

Bidder Qualifications: This section of the Specification includes several blank forms essential to the review of the ability of the Contractor. It is mandatory that the forms be completed and returned with the Bid Proposal.

Bid Item 6, Concrete Sidewalk – 4" PCCC on 4" Class 2 AB and Bid Item 7, - Concrete Vehicular Pavement – 6" PCC on 6" Class 2 AB. The contractor may choose to close the driveway and sidewalk in its entirety while they are being replaced. Concrete mix shall include an accelerant to minimize the length of concrete curing time so that the driveway and sidewalk can reopened as soon as possible subject to the approval of the City prior to delivery and placement. Contractor's work shall be done and scheduled to minimize impacts to use and operation of the parking lot by the public conducting business at the City Library and/or City Hall. Contractor shall coordinate with City on the reconstruction of the driveway and sidewalk to assure adequate break-over angles, turning radius and slope thereby improving drivability and ensure the sidewalk meets current accessibility requirements.

DESIGNATION OF SUBCONTRACTORS/SUPPLIERS

In compliance with the Subletting and Subcontracting Fair Practices Act of the Public Contract Code of the State of California, each bidder shall set forth below: (a) the name and the location of the place of business and (b) the portion of the work which will be done by each subcontractor who will perform work or labor or render service to the Contractor in or about the construction of the work in an amount in excess of one-half of one percent (0.5%) of the Contractor's Total Bid Price. Notwithstanding the foregoing, if the work involves streets and highways, then the Contractor shall list each subcontractor who will perform work or labor or render service to Contractor in or about the work in an amount in excess of one-half of one percent (0.5%) of the Contractor's Total Bid Price or \$10,000, whichever is greater. No additional time shall be granted to provide the below requested information.

If no subcontractor is specified, for a portion of the work, or if more than one subcontractor is specified for the same portion of Work, to be performed under the Contract in excess of one-half of one percent (0.5%) of the Contractor's Total Bid Price or \$10,000, whichever is greater if the work involves streets or highways, then the Contractor shall be deemed to have agreed that it is fully qualified to perform that Work, and that it shall perform that portion itself.
