NOTICE OF PLANNING COMMISSION PUBLIC HEARING FOR A TENTATIVE MAP FOR CONDOMINIUM SUBDIVISION, CONDOMINIUM CONVERSION PERMIT, DESIGN REVIEW PERMIT AND ENCROACHMENT AGREEMENT 420- 422 NAPA STREET, 114 FILBERT AVENUE TM/CCP/DR/EA 13-139

You are invited to attend a Planning Commission public hearing on the following project.

PROJECT DESCRIPTION

The applicant and property owner, Mark Rushford, on behalf of the other property owners, Donald Russo, Margaret Johnson and Naohiro Haitani, requests Planning Commission approval of a Tentative Parcel Map, a Condominium Conversion Permit to convert three existing detached single-family residences to three condominium units, a Design Review Permit and an Encroachment Agreement. The only construction associated with these permits is the construction of a retaining wall and completion of the sidewalk in front of 420 Napa Street.
