Discussion of Oct. 12th and Oct. 19th Bike Survey done by Spencer Fotsch. Survey showed on Oct. 12th a total of 2,547 bikes came to Sausalito. And on Oct. 19th a total of 1, 976 bikes came. The survey Showed the peak hours for Spandex bikers were between 9am and Noon. Rental bikers peak between noon and 4pm.
