

CITY OF SAUSALITO NOTICE OF CITY COUNCIL PUBLIC HEARING FOR RECONSIDERATION OF AN APPEAL OF A PLANNING COMMISSION DECISION APPROVING A DESIGN REVIEW PERMIT AND TREE REMOVAL PERMIT 206 THIRD STREET DR/TRP 13-122

The City Council will hold a public hearing to reconsider an appeal on the following project.

PROJECT DESCRIPTION

Leonard A. Rifkind, on behalf of Gerard Cunningham and Amy Wilson, has appealed the March 12, 2014, Planning Commission decision approving a Design Review Permit and Tree Removal Permit to allow (Planning Commission Resolution No. 2014-06) the demolition of the existing single-family residence and construction of a new two-story single-family dwelling. The project site is located at 206 Third Street, south of the intersection of Richardson Street and Third Street (APN 065-238-47). On May 27, 2014, the City Council held a hearing on the appeal and directed staff to prepare a resolution to uphold the appeal. On June 10, 2014, the City Council decided to reconsider its action on May 27, 2014. At the City Council meeting on July 8, 2014, the City Council may reconsider its action on May 27, 2014.
