- PROJECT DESCRIPTION** Applicant, Allen Fink, On Air LLC for Verizon Wireless is requesting Planning Commission approval of an amendment of a Conditional Use Permit and Design Review Permit for the replacement of three existing panel antennas with three new panel antennas and associated coaxial cables on the lattice structure at the Spencer Fire Station (Fire Station No. 2) at 300 Spencer Avenue (APN 065-181-44), which is owned by the City of Sausalito.
