NOTICE OF PLANNING COMMISSION PUBLIC HEARING FOR RECOMMENDATION TO THE CITY COUNCIL REGARDING A DESIGN REVIEW PERMIT AND TREE REMOVAL PERMIT AT 206 THIRD STREET

DR/TRP 13-122

The Planning Commission will hold a public hearing on the following project.

PROJECT DESCRIPTION

The City Council requests Planning Commission review of a Design Review Permit and Tree Removal Permit at 206 Third Street (APN 065-238-47). On March 12, 2014, the Planning Commission adopted Resolution No. 2014-06 which approved a Design Review Permit and Tree Removal Permit to demolish an existing two-story single family residence and construct a new two-story single family residence on property located at 206 Third Street (property owners, Frits and Letty Vanderlinden). Subsequently, an appeal was filed by appellants Gerard Cunningham and Amy Wilson, 208 Third Street. On July 8, 2014, the City Council heard the appeal of the Planning Commission decision and remanded the project to the Planning Commission for a recommendation on privacy concerns, view impacts, neighborhood compatibility and general consistency with the scale of structures and buildings in the neighborhood.
