DESIGN REVIEW PERMIT AND ENCROACHMENT AGREEMENT  
AT 38 WOODWARD AVENUE**

**You are invited to attend a Planning Commission public hearing on the following project.**

**PROJECT:** John McCoy, AIA, applicant; and Woodward Investments, property owner, request Planning Commission approval of a Design Review Permit, requiring Heightened Design Review Findings, for a remodel and addition to an existing single-family residence. The proposal would add 1,391 square feet of floor area and 1,115 square feet of deck area. The applicant is also requesting a recommendation of City Council approval of an Encroachment Agreement for replacement of an existing car deck within the public right-of-way at 38 Woodward Avenue (APN 064-201-13).
