

CITY OF SAUSALITO NOTICE OF CITY COUNCIL PUBLIC HEARING REGARDING AN APPEAL OF A PLANNING COMMISSION DECISION DENYING A DESIGN REVIEW PERMIT FOR 38 WOODWARD AVENUE (APN 064-201-13) DR/EA 14-196

The City Council will hold a public hearing on the following project.

PROJECT DESCRIPTION

John McCoy, Applicant, on behalf of property owner Woodward Investments LLC, has appealed the November 5, 2014 Planning Commission decision to deny a Design Review Permit (Resolution No. 2014-38) to allow for modifications and additions totaling 1,067 square feet of new floor area to an existing single-family residence, new deck area totaling 1,097 square feet, stairs and other hardscape improvements, replacement of the existing car deck within the Woodward Avenue public right-of-way. The project site is located at 38 Woodward Avenue (APN 064-201-13).
