

## CITY OF SAUSALITO NOTICE OF PLANNING COMMISSION PUBLIC HEARING FOR A DESIGN REVIEW PERMIT, ACCESSORY DWELLING UNIT PERMIT, CONDITIONAL USE PERMIT AND ENCROACHMENT AGREEMENT AT 67 MARIE STREET, APN 064-194-02 (DR/ADU/CUP/EA 14-240)

You are invited to attend a Planning Commission public hearing on the following project.

PROJECT:

Jennifer Weiss Architecture, applicant; and Carrie Byles, property owner, request Planning Commission approval of a Design Review Permit, Accessory Dwelling Unit (ADU) Permit, Conditional Use Permit and Encroachment Agreement to allow a two-story addition on the north side of the existing single family home, expansion of existing crawlspace, reconfiguration of interior space (relocating partition walls), new bathroom, new roof and fire sprinkler system. The proposal would remove an existing solarium and would add a total of 765 square feet of floor area, increasing the total floor area to 2,436 square feet. An Accessory Dwelling Unit Permit is requested for a 444 square-foot, ground level Accessory Dwelling Unit (393 square feet of the added floor area), including an exemption for off-street parking as set forth in Section 10.44.080.D.14 of the Sausalito Municipal Code. A Conditional Use Permit is required for exceptions to the ADU criteria for lot coverage and floor area, as set forth in Section 10.44.080.F.1 of the Sausalito Municipal Code. The applicant is also requesting a recommendation of City Council approval of an Encroachment Agreement to allow a portion of the off-street parking space for ADU to be located within the public right-of-way at 67 Marie Street (APN 064-194-02).
