

Re: Request to Adjust Hours of Exclusive Use of the MLK Park Playground

Madam Chair and Commission Members:

This letter is on behalf of the Real Estate Committee of the Board of Trustees of the Lycée Français de San Francisco (the "Lycée") in support of the Lycée's request to adjust the exclusive use of the MLK Playground during Lycée school days from 3:30 p.m. until 5:30 p.m. The Lycée is a nonprofit French-immersion school with over 1,000 students and 300 families. The Sausalito campus of the Lycée hosts over 200 students and 40 teachers and staff members.

The Lycée currently leases buildings 3, 4 and 5 at the complex located at 100 Ebbtide Avenue in Sausalito (the "premises") from the City of Sausalito. The lease, signed in 2013 for a 5-year term, may be renewed for 3 additional 5-year terms, totaling a 20-year lease. At considerable debt-financed expense, as well as tuition increases, the Lycée improved the City of Sausalito's property and, over the course of the past 3 years, the Lycée opted to increase the square footage space. Consequently, the monthly rent increased from \$42,000 to over \$65,000 at present.

On Wednesday, May 20, 2015, the Commission will consider the Lycée's request to adjust the exclusive use of MLK Playground by the Lycée for up to two additional hours. Unfortunately, the Director of the Parks and Recreation Commission recommended against approval of the Lycée's request primarily because "[T]he Lycée Français programs are not part of the regular school day, and a playground structure is not needed for the Playworks program," noting also that the Lycée pays only \$1 a year for the lease of the MLK Playground.



We respectfully **disagree** with the Parks and Recreation Director's reasoning because of some inaccuracies and a failure to acknowledge the heavy financial investment borne by the Lycée for the benefit of land ultimately owned by the City of Sausalito.

First, as a point of clarification, the Playworks program is part of the core curriculum of the school, and it is well integrated into the Lycée's regular school day.

While it is true that the Lycée pays nominal rent for the use of the Playground, the total investment made by the Lycée to the premises in general, and the MLK Playground in particular, **is in the millions**. The improvements and the overall financial investment were made for the benefit of not only the Lycée community but also the children utilizing the MLK Playground. Thus far, the Lycée's investment in the City of Sausalito's property is as follows:

- ➤ \$4.3M in improvements to the facilities;
- > \$790,000 for the MLK Playground at issue;
- ➤ \$1.9M in rents, permits, traffic studies and utility payments to date

For a grand total of — \$7M

In addition to the significant investment and the monthly \$65,000 rent paid to the City of Sausalito, the Lycée is responsible for all maintenance and repair work to the MLK Playground, a responsibility that would otherwise fall to the Sausalito taxpayers.

Our investment is therefore substantial. And it is borne by the parents of the Lycée. We represent a diverse socioeconomic group — there are parents with means, but there are many parents who sacrifice for the sake of their children's education. And again, the group that would suffer the most by your rejection of the Lycée's request would be the children of working parents as a result of their reliance on the Lycée for aftercare.

A final compelling reason to allow the Lycée additional time for its exclusive use involves the safety of not only Lycée children, but also children from the general public. When local residents arrive after 3:30 pm, the quality of supervision by the Lycée aftercare staff for the Lycée children becomes compromised, especially as children from the Lycée aftercare mix with children (including infants and toddlers) from outside the Lycée. We are concerned that Sausalito is inviting members of the general public into the playground. Not just residents of Sausalito, but anyone. By extending this invitation, without limitation, Sausalito invites liability for any harm that may come to the children.



For these reasons set forth above, we ask that the Commission allow additional time for Lycée children to maintain safe access to the MLK Playground generously donated by the Lycée community.
