- PROJECT DESCRIPTION** Larry Mindel, on behalf of Poggio LP, is requesting a Sign Permit for business identification awnings and signage at Poggio, 777 Bridgeway (APN 065-063-46), within the Downtown Historic Overlay Zoning District. The project includes the modification of four existing awnings with new fabric, signage, and illumination and the modification of eight existing planter boxes with new paint and signage.
