<b>PROJECT DESCRIPTION</b>	Justin Ha is requesting to modify a condition of approval for Heavenly Couture, a formula retail establishment located at 749 Bridgeway in the Central Commercial Zoning and Downtown Historic Overlay District, to extend the business hours from 9:30 a.m. to 8:00 p.m., to 9:30 a.m. to 10:00 p.m. A Conditional Use Permit was approved by the Planning Commission on March 25, 2015, to allow Heavenly Couture at this location.
