

## CITY OF SAUSALITO NOTICE OF ZONING ADMINISTRATOR PUBLIC HEARING FOR AN ADMINISTRATIVE DESIGN REVIEW PERMIT AND VARIANCE 2 ALEXANDER AVENUE / ADR-VA 13-310

You are invited to attend a Zoning Administrator public hearing on the following project:

PROJECT DESCRIPTION

Mid-Cal Construction, Inc., applicant, on behalf of property owner Edward Fotsch, is requesting an Administrative Design Review Permit and a Variance to allow for the construction of a 1,116 square-foot residential pier and deck/boat lift that would extend into the San Francisco Bay. The pier and deck/boat lift would extend beyond the parcel's rear property line and onto City property. The requested Variance would allow the project to encroach into the required rear-yard setback of the property. The project is subject to Heightened Design Review (APN 065-303-05 and 065-303-20).
