

CITY OF SAUSALITO NOTICE OF PLANNING COMMISSION PUBLIC HEARING A DESIGN REVIEW PERMIT AT 556 SAUSALITO BLVD (DR 15-171)

You are invited to attend a Planning Commission public hearing on the following project:

PROJECT DESCRIPTION

Drafting Green, on behalf of J & V LLC, is requesting a Design Review Permit (DR 15-171) at 556 Sausalito Boulevard (APN 065-222-13) for an interior remodel to the two units at 556 Sausalito Boulevard which will add 10 new square feet of floor area, repair of the existing parking bridge, raising the existing garage roof from 31'-7" to 33'-7" to accommodate the new concrete construction of the parking bridge, and the addition of a 74 square foot new deck off the second floor above the lower deck. Three protected oak trees will be removed two of which are currently dead and are not impacted by the proposed design. One new 15 gallon oak tree will be planted to replace the protected oak tree being removed for the proposed deck.
