DESIGN REVIEW AND CONDITIONAL USE PERMIT REQUESTS
FOR SAUSALITO TOWERS (DR-CUP 14-329)

5 – 65 RODEO AVENUE (APN: 064-133-04)

The Planning Commission will hold a public hearing on the following project.

- PROJECT DESCRIPTION** Peter Rose, applicant, is requesting Approval of a Design Review Permit to construct a 2,148 square-foot, two-level building adjacent to the existing swimming pool area for a manager's unit and fitness center for the Sausalito Towers located at 5 – 65 Rodeo Avenue. In order to construct the additional apartment unit (manager's unit), the applicant is also requesting an amendment to Conditional Use Permit No. 194 to increase the number of authorized apartment units from 90 to 91. At the Planning Commission meeting of December 9, 2015, the Planning Commission will conduct a hearing on the request.
