

# CITY OF SAUSALITO NOTICE OF PLANNING COMMISSION PUBLIC HEARING FOR A DESIGN REVIEW PERMIT (DR 13-311)

#### You are invited to attend a Planning Commission public hearing on the following project:

## PROJECT DESCRIPTION

Michael Fisher, applicant and property owner, is requesting a Design Review Permit for a 409 square foot addition to the existing 1,385 square foot residence at 60 Edwards Avenue (APN 065-293-32). The proposed project will renovate an existing lower-level storage area and infill below existing deck areas to create a new bedroom, bathroom laundry room, and a new staircase for interior access between the upper and lower levels. Additionally, 49 square feet of new deck space will be added to the existing decks to improve existing exterior staircase access and flow.
