

CITY OF SAUSALITO NOTICE OF PLANNING COMMISSION PUBLIC HEARING FOR REVIEW OF A LANDSCAPE PLAN FOR A PREVIOUSLY-APPROVED PROJECT - 168 HARRISON AVENUE ("TANGLEWOOD") DR-EA-ADU 15-191

You are invited to attend a Planning Commission public hearing on the following project:

PROJECT DESCRIPTION

On July 1, 2015, an application was filed by Michael Rex Architects, on behalf of property owners Asriel and Carmela Levin, requesting Planning Commission and Historic Landmarks Board approval of a Design Review Permit, Encroachment Agreement, and Accessory Dwelling Unit Permit for improvements to 168 Harrison Avenue ("Tanglewood"), a property listed on the Local Historic Register (APN 065-091-10). On January 6, 2016, the Planning Commission and Historic Landmarks Board approved the requested entitlements, subject to conditions. Condition of Approval 1 requires submission of the landscape inventory and other related landscape documents as referenced in the project's Landscape Status Report for review by the Planning Commission. On April 27, 2016, the Planning Commission will review the documents and provide direction regarding the project's landscape plan.
