Ray Cassidy, on behalf of the property owner Martin Coyne, is requesting a Design Review approval to construct a 2,901 sf, three-level, single-family dwelling on an undeveloped parcel with a 418 square-foot attached garage, and 403 square foot second-level patio at 168 Santa Rosa Avenue (APN 065-112-33). Landscape improvements are proposed throughout the site. The applicant is also seeking a Tree Removal Permit to remove 10 protected trees and 2 undesirable trees located in the proposed construction area. 11 replacement trees are proposed on-site.


