

**DESIGN REVIEW PERMIT AT**  
**2 CRECIENTA DRIVE (DR 15-319)**

You are invited to attend a Planning Commission public hearing on the following project:

- PROJECT DESCRIPTION** Heckman Architects, on behalf of property owners Familia De Frijoles, LLC and National Housing Group, LLC, is requesting a Design Review Permit for the demolition of an existing 1,310 square foot, two-level, single-family dwelling and rebuild with a new 3,903 square foot, two-level, single family dwelling at 2 Crecienta Drive (APN 064-252-11). The project includes a newly attached 420 square foot, two-car garage and re-roof of an existing detached 689 square foot, two-car garage.
