

CITY OF SAUSALITO NOTICE OF PLANNING COMMISSION PUBLIC HEARING FOR A DESIGN REVIEW PERMIT AT 25 GLEN COURT (DR/TRP 15-302)

You are invited to attend a Planning Commission public hearing on the following project:

PROJECT DESCRIPTION

OXBStudio, on behalf of property owners Richard North and Elizabeth Diana, is requesting approval of a design review permit at 25 Glen Court (APN 064-112-10) to remodel an existing 933 square-foot (sf), one-level, single-family residence and build a 471 sf second story addition. The project includes converting existing gabled roofs to new flat roofs, a roof deck with a trellis on the second level, and a trellis on the main level patio. The application is also seeking approval of a tree removal permit to remove a mature palm tree at the northwest corner of the lot.
