EMERGENCY [HOMELESS] SHELTERS  
ZOA 15-008**

**You are invited to attend Planning Commission public hearing on the following amendments:**

**PROJECT DESCRIPTION:** Zoning Ordinance Amendments to modify the Emergency [Homeless] Shelter provisions in Sausalito Municipal Code Section 10.28.080. Specifically, the amendments being considered include:

- Amendment to Sausalito Municipal Code Section 10.28.080.D.2 to increase the shelter capacity from a maximum of 20 beds to a maximum of 23 beds
- Amendment to Sausalito Municipal Code Section 10.28.080.I.2 to decrease the maximum length of stay from 90 days in a 365-day period to 30 days in a 365-day period.

There are no proposed changes to the sites in the Emergency Shelter Overlay Zone, which includes: Police Station on Caledonia Street, Fire Station on Johnson Street, Downtown Parking Lot areas, Ferry Landing area and Spinnaker Restaurant area.
