PROJECT DESCRIPTION

Derek Weller, on behalf of property owners David and Susan Kelley and Lauren Kelley requests approval of a **Condominium Conversion Permit** and a **Tentative Map** to convert the existing two-unit residential duplex into a two-unit condominium covenant located at 316-318 Sausalito Boulevard (APN 065-252-40). The requested condominium conversion does not involve any physical improvements or modifications. The conversion will result only in a change of the form of ownership of the property from tenancy in common ownership to condominium ownership (CCP-TM 15-337).
