

## CITY OF SAUSALITO NOTICE OF PLANNING COMMISSION PUBLIC HEARING FOR A DESIGN REVIEW APPLICATION AND TREE ALTERATION PERMIT AT 2 CRECIENTA DRIVE (DR-TP 15-319)

You are invited to attend a Planning Commission public hearing on the following project:

## PROJECT DESCRIPTION

Heckman Architects, on behalf of property owners Familia De Frijoles, LLC and National Housing Group, LLC, is requesting a Design Review Permit for the demolition of an existing 1,310 square foot, two-level, single-family dwelling and construction of a new 3,903 square foot, two-level, single family dwelling at 2 Crecienta Drive (APN 064-252-11). Landscaping improvements, including terraced retaining walls, are proposed throughout the site. The project includes a newly attached 420 square foot, two-car garage and re-roof of an existing detached 689 square foot, two-car garage. The applicant also seeks a Tree Alteration Permit for maintenance performed on a protected Coast Live Oak tree located at the rear of the parcel.
