

## CITY OF SAUSALITO NOTICE OF PLANNING COMMISSION PUBLIC HEARING FOR A DESIGN REVIEW PERMIT AND ACCESSORY DWELLING UNIT PERMIT AT 211 WEST STREET (DR-ADU 15-228)

You are invited to attend a Planning Commission public hearing on the following project:

## PROJECT DESCRIPTION

Daren Iguchi, architect on behalf of property owners Steve Engelbrecht and Anna Avittal, is requesting a **Design Review Permit**, subject to **Heightened Design Review**, for the demolition of an existing 827 square-foot single-family residence and construction of a new 1,971 square foot, three-level, single family residence, and 572 square foot detached three-car garage at 211 West Street (APN 065-231-17). The Design Review Permit request includes the location of the residence at a distance of 9.5 feet from a neighboring structure of an adjoining lot; An **Accessory Dwelling Unit Permit** request for a 296 square foot accessory dwelling unit above the detached garage.
