PUBLIC HEARING FOR A DESIGN REVIEW PERMIT AND  
AN ENCROACHMENT AGREEMENT AT  
112 MARION AVENUE (DR-EA 16-012)**

**You are invited to attend a Planning Commission public hearing on the following project:**

- PROJECT DESCRIPTION** Taylor Yang Inc., on behalf of property owner Darshan Brach, is requesting a Design Review Permit to allow a 946 square foot addition to the existing 1,469 square foot single-family residence and seeking a recommendation for City Council approval of an Encroachment Agreement for a 154 square foot addition to the existing car deck located in the public right-of-way at 112 Marion Avenue (APN 065-266-04). The project will expand the existing residence near the front and rear of the parcel for the addition of a master suite, two bedrooms, bathroom, laundry room, one additional on-site parking space, construct terraced retaining walls, and other related site improvements.
