NOTICE OF CITY COUNCIL PUBLIC HEARING REGARDING AN APPEAL OF A PLANNING COMMISSION DECISION DENYING A DESIGN REVIEW PERMIT AND TREE ALTERATION PERMIT (DR-TP 15-319)

2 CRECIENTA DRIVE (APN 064-252-11)

The City Council will hold a public hearing on the following project.

PROJECT DESCRIPTION

Appeal of a Planning Commission decision denying a **Design Review Permit** to demolish an existing single-family residence and construct a 3,903 square-foot, two-level, single-family residence, re-roof an existing detached two-car garage, construct two new driveways with a maximum slope of twenty-five percent, construct terraced retaining walls, and a tree alteration permit at 2 Crecienta Drive. National Housing Group LLC and Frijoles De Familia, LLC, property owners, appealed the July 20, 2016 Planning Commission decision. At the City Council meeting of September 27, 2016, the City Council will conduct a hearing on the appeal.
