NOTICE OF PLANNING COMMISSION PUBLIC HEARING FOR A DESIGN REVIEW PERMIT TO ADD 417 SQUARE FEET OF FLOOR AREA TO A SINGLE-FAMILY RESIDENCE; AND A VARIANCE PERMIT TO EXPAND EXISTING NON-CONFORMING LOT COVERAGE BY 408 SQUARE FEET AT 1 CLOUD VIEW CIRCLE (DR/VA 16-099)

YOU ARE INVITED TO ATTEND A PLANNING COMMISSION PUBLIC HEARING ON THE FOLLOWING PROJECT:

PROJECT DESCRIPTION

Michael Rex of Michael Rex Architects, on behalf of the property owners Jennifer and Michael Wechsler, is requesting Design Review approval to construct building additions totaling 417 square feet to the single family residence at 1 Cloud View Circle (APN 065-153-07). The additions provide additional living space in the kitchen, dining room, and master bathroom; and create a new sitting room and master bedroom. The applicant is also seeking a Variance Permit to exceed the maximum allowable building coverage area. The existing building coverage is 2,748 square feet, and is above the 2,210 square foot maximum permitted for the lot. The project proposes to increase building coverage to 3,156 square feet, which is 408 square feet above the existing building coverage area and 946 square feet above the maximum permitted building coverage for the lot.
