PROJECT DESCRIPTION

Crome Architecture, on behalf of Mollie Stone's Markets, requests approval of 1) a Design Review Permit for the following improvements: remodel of storefront façade with new roof features including an increase in building height from 19'-3" to 23'-3", new outdoor seating area with related hardscape and landscape improvements, and parking lot restriping to the existing full-service supermarket at 100 Harbor Drive; and 2) a Minor Use Permit for outdoor dining at the seating area (APN 063-130-02).
