PROJECT DESCRIPTION

Daren Iguchi, architect on behalf of property owners Steve Engelbrecht and Anna Avittal, is requesting a Design Review Permit, subject to Heightened Design Review, for the demolition of an existing 827 square-foot single-family residence and construction of a new 1,971 square foot, three-level, single family residence, and 572 square foot detached three-car garage at 211 West Street (APN 065-231-17). The project also entails an Accessory Dwelling Unit Permit to construct a 285 square foot accessory dwelling unit above the detached garage.
